How to Report Notifiable Diseases

All Georgia physicians, laboratories, and other health care providers are required by law (OCGA 31-12-2) to report patients with suspected/confirmed cases of notifiable disease.

What Must Be Reported

- Both clinical diagnoses and laboratory-confirmed cases of notifiable diseases are reportable
- **Suspect cases as well as confirmed ones, especially for diseases that require immediate public health actions**
- For a list of ND diseases, see NOTIFIABLE DISEASE CONDITION REPORTING in the Toolkit.
- **All reports should include patient demographics (name, date of birth, home address, phone number, and parent name), copy of lab result or the name of the facility the patient was tested at, and last day the child was at daycare**

To Whom and How

- Report to the Northwest Public Health District
 - Phone: 706-295-6656 Option 0 ***preferred method for daycare staff**
 - Staff will ask you the illness you are reporting and what county your facility is in and what county the patient lives in
 - Fax: 706-802-5342
 - After-Hours Public Health Hotline: 1-866-PUB-HLTH or 1-866-782-4584
 - **This number is for urgent public health issues and emergencies only**
 - Examples include:
 - Reporting a suspect measles case
 - Please use this line only for time sensitive public health concern or public health urgency

Following Up and Additional Requirements

- Once a case is reported, public health staff may conduct further investigation and follow up per our policies and procedures including contact tracing, diagnosis confirmation, and laboratory follow-up.
- Please provide any additional information you are able to obtain to support the reporting and response efforts as this will speed up the process so that our staff can confirm illness and/or give public health recommendations in a timely manner.
- We do receive rumor calls about cases and can follow up if it is a notifiable condition reportable to public health and/or is outbreak related. Please ensure we are provided with the patient's name, date of birth, facility that tested/diagnosed the patient, and the disease or illness that the patient might have.

Outbreaks

General Outbreak Definition

- Two or more people with a similar illness following a documented common exposure within the state of GA.
- Common exposures may include consumption of a common food item, attendance at the same event, or close contact in daycare or extracurricular activity.
- Illnesses occurring among children at the same daycare or facility are considered to be an outbreak if it is clear that more than one child was exposed at the same time, or the number of illnesses is greater than what is expected.

Measles Outbreak Definition

- One case is considered an outbreak. If you receive a report of a confirmed or suspected measles case, please notify our office immediately by calling 706-295-6656 and selecting option 0. If it is during afterhours, please call 1-866-PUB-HLTH (1-866-782-4584) to report.

Reporting Outbreaks of Seasonal Influenza, RSV, and Other Common Conditions

- An increase in seasonal influenza or RSV above the expected level or normal occurrence for your daycare or group during a given period is an outbreak.
- We also encourage daycare staff to report the situations below:
 - Rapid increases in absenteeism related to respiratory illness
 - Absenteeism at 10% or more in the entire facility in a short period of time (1-3 days)
 - Multiple epidemiologically linked cases within a classroom or cohort
 - Severe illness, hospitalization, or unusual disease patterns
 - Concerns for ongoing transmission that may require public health guidance

Vaccine Preventables

Vaccines are available for diseases like chickenpox, hepatitis A and B, measles, and whooping cough (pertussis), among many others listed here: <https://www.cdc.gov/vaccines/by-disease/index.html>

Routine vaccines prevent serious illness and hospitalization and are an important part of childhood disease prevention. See common questions about vaccine preventable diseases below.

Where can I find the most up-to-date childhood vaccination schedule?

What do I do if a child has a vaccine-preventable infection?

- Report confirmed and suspect cases to the Northwest Public Health District.
- Follow daycare sick policy, guidelines and recommendations.
- Stay in contact with public health staff as we may have additional recommendations which could include sending out a public health letter to parents, monitoring specific at-risk exposed individuals, and restricting the sick child from returning to daycare.

Who is considered “at-risk” for vaccine-preventable diseases/infections?

- Those most at-risk for vaccine-preventable diseases include individuals who are not up-to-date on their vaccinations.
- In general, individuals who are immunocompromised, pregnant, older, younger, and healthcare workers are more at risk of contracting infectious diseases.

Frequently Asked Questions

What should I do if a parent reports a child with a notifiable disease that is reportable to public health?

- If staff from our office have not already contacted staff at your facility, please contact our office and our staff can verify if we have received the report and if we have any specific recommendations. Some parents do not return calls to our staff and we may not know what daycare center the child attends. Other times, you may be the first to report the child's condition to our office. Many reports are delayed and some may not be reported at all.
- If a parent reports that their child has measles, call our office immediately during regular business hours at 706-295-6656 option 0 or if during after hours, holidays, or weekends call our public health hotline at 1-866-PUB-HLTH or 1-866-782-4584. Staff will need the child's name, date of birth, family phone number, address, and what medical provider or facility the child was diagnosed at. Our staff must confirm the diagnosis or have a high suspicion for measles for public health to recommend notification and further action.

What illnesses are currently in our community?

- There are some websites that have detailed information on illnesses by county. GA DPH has viral respiratory disease reports during respiratory season and the CDC has a Respiratory Illness Data Channel website. Other times, you may need to call our office and speak to one of our epidemiologists.

Frequently Asked Questions

What are the most common outbreaks that are reported in our district in daycare settings?

- GI illnesses including norovirus (stomach flu or stomach bug).
- Respiratory/Rash Illnesses including seasonal Influenza, RSV, hand, foot, and mouth disease, COVID-19, pertussis, and chickenpox.

What should I know about norovirus in a daycare setting?

- Norovirus is a highly contagious virus that can spread quickly because only a small number of viral particles are needed to cause infection and the virus can survive on surfaces for days to weeks if not properly cleaned and disinfected.
- Symptoms include nausea, vomiting, watery diarrhea, and stomach cramps. Some individuals may also have a low-grade fever, headache, body aches, or fatigue.
- Clean and disinfect contaminated surfaces with an Environmental Protection Agency (EPA) registered disinfectant effective against norovirus or a freshly prepared chlorine bleach solution.

What are some ways that we can reduce illness at our facility?

- Teach how to wash hands appropriately and when to wash hands.
- Use respiratory etiquette with covering cough and sneeze.
- Clean, sanitize, and disinfect commonly touched items regularly.
- Follow facility sick policy.
- Encourage parents to talk to their provider about vaccinations.
- Take steps for cleaner air at your facility.
